RULES AND REGULATIONS: VOCAL, INSTRUMENTAL & DANCE April 26, 2020, 2:00 pm

- Members will have the opportunity to make entries via the paper entry form by April 9. Members will be able to request a time slot by calling the Extension Office by April 15. Forms are on the Grant County website at <u>https://grant.extension.wisc.edu</u>
- Members will need to pay the Grant County Junior Fair Exhibitor fee of \$3. This fee will cover any and all fair entries for that 4-H member. Mail entries to the Grant County Extension Office, 916 East Elm St, Suite A, Lancaster, WI 53813 on or before April 9.
- 3. Participants in the vocal solo/duet or solo/duet instrumental and dance category may also participate as a member in the Grant County Music Club Contest in their 4-H club.
- 4. The solo/duet contest will be split into four age divisions, grades 3-5, 6-7, 8-9 and grades 10 and over. Each member may have one vocal entry, one instrumental and one dance entry. This should eliminate members from competing against themselves.
- 5. Participants will receive a fair premium for their performance.
- 6. Accompanists for any musical solo or ensemble may or may not be provided by 4-H club members and may or may not be adults. Tapes, CD or DVD's accompaniment with background vocals are not permitted.
- 7. Pantomiming or lip synching to tapes CD or DVD's, karaoke, or background singing does not give an opportunity for musical expression on the part of participants, it is not permitted.
- 8. To keep the selection shorter, excerpts may be taken from longer pieces, one movement may be done, or repeats may be eliminated.
- 9. All parts of the performances, including songs, jokes, movements, props, dress, etc. should be in good 4-H taste. No references to alcohol or drugs can be used. As in all 4-H events, good sportsmanship and support of others is expected.
- 10. The ratings will be blue, red and white.

The following types of music ensembles and dance ensembles can be entered in the county contest:

DANCE SOLO: Dancing to music provided by any type of instrumental group or by recording, i.e. folk, ethnic, tap, jazz, ballet, etc. (Maximum 10 minutes)

DANCE DUET: Two performers dancing to music provided by any type of instrumental group or by recording, i.e. folk, ethnic, tap, jazz, ballet, etc. (Maximum 10 minutes)

VOCAL SOLO: Defined as a single singer, accompanied or unaccompanied, performing a musical selection. (3-4 minutes)

VOCAL DUETS: Defined as two singers accompanied or unaccompanied. (3-4 minutes)

INSTRUMENTAL SOLO: A single instrumentalist performing a musical selection. (3-4 minutes) **INSTRUMENTAL DUET:** Two instrumentalists performing a musical selection. (3-4 minutes)

GRANT COUNTY 4-H MUSIC CONTEST RULES AND REGULATIONS: Club Performance

The Grant County 4-H Music Contest provides an opportunity for 4-H members of all ages to share the excitement and commitment necessary to prepare for a public performance. Involvement in these contests builds poise, self-confidence and the discipline needed to present a performance to an audience. 4-H members develop musical talents while sharing the fun of working together. Below are the 4-H Music Contest guidelines:

- Club managers can register their club in the group contest by completing the paper entry form by April 9. Club managers will be able to request a time slot by calling the Extension Office by April 15. Forms are available on the Grant County website at <u>https://grant.extension.wisc.edu</u>
- 2. Each club is allowed one entry. There is no entry fee.
- 3. All music ensembles and dance ensembles will be limited to twelve (12) minutes maximum to present a performance, per State Fair requirements.
- 4. It is recommended that no more than five (5) minutes be allowed between groups for taking down and setting up properties.
- 5. All groups will be awarded a blue, red or white ribbon.
- 6. Participants must be 4-H members in good standing.
- 7. Two judges will evaluate performances individually and their scores will be averaged at the end. In case of a tie, judges will be asked to confer.
- 8. Pantomiming or lip synching to tapes, CD's or DVD's does not give an opportunity for musical expression on the part of participants. It is not permitted.
- 9. Ensemble performance will be based on a combination of technical and aesthetic evaluations. Musical expression will be a major consideration in this evaluation. Stage movements and props, along with theme development, will be evaluated in reference to how they support the whole ensemble's musical performance.
- 10. All parts of the performances, including songs, jokes, movements, props, dress, etc. should be in good 4-H taste, no references to alcohol or drugs. As in all 4-H events, good sportsmanship and support of others is expected.
- 11. The following types of music ensembles and dance ensembles can be entered in the county contest:

VOCAL ENSEMBLES - A vocal ensemble is defined as having three or more singers with or without piano or other instrumental accompaniment, with or without costuming or staging.

INSTRUMENTAL ENSEMBLES - An instrumental ensemble is defined as having three or more instrumentalists playing standard musical instruments with or without piano accompaniment, and with or without costuming and staging.

NOVELTY ENSEMBLES - A novelty ensemble is defined as having three or more singers or instrumentalists in any combination of singing or playing. In this category the performers must express themselves vocally and/or instrumentally or they may combine vocal and instrumental music.

DANCE ENSEMBLE - A dance ensemble is defined as having three or more dancers doing dances to music provided by any type of instrumental group or by recording, i.e. folk, ethnic, square dancing, etc.
