4-H Shooting Sports

The Grant County 4-H Shooting Sports practices monthly from January - June and host fair competition shoots in July and August. Shooting disciplines offered are Air Rifle, Archery, Air Pistol, .22 Rifle and Shotgun. In the winter months we are able to practice Archery and Air Rile indoors and the summer months we practice all disciplines outside. All equipment to participate is provided but youth are welcome to bring their own to practice if they prefer. Equipment safety checks will happen at the beginning of practice.

Participant Requirements:

- Archery and Air Rifle is open to any youth in 3rd grade and above.
- 22 Rifle, Air Pistol and Shotgun: youth must be 12 years or older and have completed hunter safety to participate.
- Members must enroll in one or more of the following projects they plan to practice in via 4hOnline by April 1; Air Rifle, Air Pistol, Archery, .22 Rifle. Shotgun or Shooting Sports.
- If you plan to compete in a fair competition shoot youth must attend at least two practices to participate in Fair Shoots.

Practices:

Practices will begin at 1:00 pm and usually last less than 2 hours. Winter/Spring practices will be at the Tri County Archery, 9145 Co Line Rd, Platteville, WI 53818 this is just outside of Arthur heading toward Rewey off of County Rd A.





Adult Leader Training Info

Adult Leaders:

All volunteers need to complete **Title IX Reporting training** before being approved.



After adult leaders submit their 4-H online

enrollment, you may see that you need to complete the Title IX Reporting Training. This is a training for all adult volunteers. It is an online training that will take around an hour; but it is self-paced so you can stop and complete it later if you need.

To get to the training; you will need to click on this link:

https://youthtraining.compliance.wisc.edu/

You only need to take Sections 1 and 2 of this training. YOU DO NOT NEED TO TAKE section 3.

To take the training:

- 1. Click on the above link
- 2. Computer users: Use "Click Here to Start" in the training Instructions or "Section 1" on the red bar at the top of the page.
- Phone/Tablet users: Click on "Menu" in the red bar at the top of the screen
- 3. Sign up using the name and email that you use in 4HOnline.
- 4. For "what program are you seeking certification for?" type "**4-H**". Do not type in your county, club, project, or role. Only type in "4-H"
- 5. Leave the NetID field blank.
- 6. To complete requirements for 4-H, you must finish Section 1 and Section 2. **Do NOT complete Section 3.**

There will be a delay between completing the training and the recording in 4-H Online. The delay may be around a week before it shows up as complete in your 4-H profile.

Cats

a. Change the time of judging cats to the first Sunday of the fair at 10:30am (August 11, 2024). Cats would come in at 9am and be in place by 10am. Cats will be released after the show.

Crafts

- a. Add Diamond Art
- b. Add Stain Glass

Dioramas

- a. Add two new classes
 - i. Science fiction class (aliens, star wars, dragons, etc)
 - ii. Natural science class (dinosaurs, solar system, etc)

Dog

- a. Change the times
 - i. Obedience at 3pm
 - ii. Showmanship at 4:30pm
 - iii. Agility at 5:30pm
 - iv. Costume contest 7:30pm
- b. Remove rally class.
- c. Add a Division A on leash under Tunnelers.
- d. Split the showmanship classes up more to
 - i. Beginner, grades 3-4
 - ii. Junior, grades 5-6
 - iii. Intermediate, grades 7-9
 - iv. Senior, grades 10 and over

Foods

- a. Add a sour dough bread category.
- b. Expand the yeast bread category to be more specific to white, wheat, or rye.
- c. Add a dried fruit category.

Horses

a. Add Walk/Trot Pleasure Class for Ranch for beginner and advance.

Shooting Sports

a. Add back in the fairbook that all participants must attend two practices from January to June to be eligible for competition in any of these events.

Grant County Fairbook changes continued....

Beef

- a. Change the load out time to 2pm to allow exhibitors to participate in other activities like kiddle showmanship/master showmanship.
- b. Add under premium list a Pair of calves must be breeding (bull or heifer).

Chickens

- a. Require that showmanship back tags must be worn.
- b. Split Class 11 (Feather Legged Bantam Class) into 2 classes
 - i. Feather Legged Bantam Rose Comb class
 - ii. Feather Legged Bantam Single Comb class

Goats

- a. Add class for Sannen Breed.
- b. Eliminate Dam & Daughter for dairy and market (ribbon only class).
- c. Herd Class for dairy and market (ribbon only class).
- d. Divide the showmanship classes (one for meat and one for dairy). Exhibitor must choose when they sign up on the fair entry form prior to fair.
- e. Add a rule that all goats must be castrated prior to fair identification.

Rabbits

- a. Change "all classes are eligible for Champion" to "only classes 3-5 are eligible for Champion.
- b. Remove "Standard" under the Rex class and add it under the Fancy Large class.
- c. New rule: 32 rabbits total per exhibitor/household. They must by identified on or before July's identification night by the ID form. There will be no switching of rabbits with any other household member.
- d. REMINDER: All rabbits must be tattooed only, no markers used.

Sheep - from livestock committee

- a. Change of wording on rule #12
 - i. Current rule Animals must be identified with official scrapie ear tag. The scrapie ear tag or official scrapie identification MUST BE visible at all times during weigh-in and identification at the fair.
 - ii. Change to Animals must be identified with official scrapie tag at time of fair identification. The scrapie tag must be visible at all times during the weigh-in and identification at the fair.
- b. Lambs must be castrated prior to fair identification.
- c. Change the sheep weigh in time from noon to 1pm, to noon to 12:30pm.
- d. Change the mandatory meeting to 1pm.
- e. Change of wording on rule #10
 - i. Current rule Beginner sheep showman can have the option to use halters in class.
 - ii. Change to Anyone can use a halter.

Auction – from livestock committee

- a. Leave minimum weights for pigs and lambs but change maximum weights
 - i. Pigs get paid up to 315lbs for sale
 - ii. Lambs at 165lb for top limit

Poster Contest for the Grant County Fair

The Grant County Fair is continuing our poster contest for students to participate in 7th, 8th, and 9th grades. If you choose to participate, all entries must be in to the Grant County Fair, 916 E. Elm Street Suite B, Lancaster, WI 53813 **no later than 3:00 p.m. on May 3, 2024.** The sooner the better. No entries will be accepted after that date and time. Below are the guidelines to enter along with a form to be completed that gets attached to the back of each poster.

Contest Rules

- A fully completed entry form must be attached to the back of the poster to make it eligible for judging. No other entry forms will be eligible for participation.
- Any media may be used to create a flat or two-dimensional effect (paint, crayon, colored pencil, charcoal, paper or other materials on regular poster) please no computer imagery
- Poster size must be between 8.5" x 11" and 12" x 18".
- Posters should be packaged so they remain flat when sent for judging.
- All posters must be created by an individual student rather than a team of students.

The 2024 title **"It's Kind of a Pig Deal"**, the date **"August 14-18, 2024**", and **"Grant County Fair"** must be on your poster. (Don't use any other title.)

An individual student may only enter in one grade level.

Entry forms should be submitted to the Grant County Fair, who will contact the winners for prize distribution. The members of the Grant County Fair Board shall sponsor the contest. The contest deadline is **May 3, 2024.**

Poster Evaluations

• The posters are evaluated based on visual effectiveness, originality, and neatness.

Prizes

- First place entry in grade 7th, 8th, and 9th will receive 1 season pass and \$25.00.
- Second place entry in grade 7th, 8th and 9th will receive 1 season pass and \$20.00.
- Third place entry in grade 7th, 8th and 9th will receive 1 season pass and \$15.00.

All entries will be judged by the Grant County Fair Board. An email went out to all 4-H leaders and art teachers at surrounding schools. We will get in touch with the poster contest winners as soon as they are judged. Be creative and have fun! Some of the top posters will be displayed at the fairgrounds all summer.

The arts are for anyone! No matter your grade level or interest, there is something for you to try and learn through the 4-H Arts. The goal of the 4-H Communication Arts Day is to give youth (5K-13th Grade) an opportunity to express their creativity, while also developing skills in a supportive and encouraging environment.

The 4-H Communication Arts Day Contest will have seven divisions.

VOCAL

- SPEAKING
- ♦ ARTS & CRAFTS

- ♦ INSTRUMENTAL
- DEMONSTRATION
- PHOTOGRAPHY

DANCE

All performance and exhibits must have been performed, completed or taken after October 1, 2023. Entries in Vocal, Instrumental, Dance, Speaking and Demonstrations are eligible for fair premiums. Arts & Crafts and Photography exhibits will be ribbon only and eligible for peer choice awards. Cloverbuds will be celebrated for their participation receiving age appropriate ribbon and premium in eligible divisions.

Members must be enrolled in the 4-H project they are exhibiting in before April 1, 2024. A \$4 Grant County Junior Fair Exhibitor fee will be required for those who enter the Vocal, Instrumental, Dance, Speaking and Demonstration divisions. This fee will cover the exhibitor fee for that 4-H member.

Cloverbuds can bring a total of 4 entries for the day, but no more than 2 entries from the same division. Members grades 3 and over can bring a total of 7 entries for the day, but no more than 2 entries from the same division.

Entry forms and fee can be dropped off at the Extension Office by **April 5 by 4:00 pm** or postmarked on or before April 5. Mail entry forms and fees to the Grant County Extension Office at 916 E Elm Street, Suite A, Lancaster, WI 53813. Communication Arts Day Divisions

VOCAL DIVISION:

A vocal performance is singing with or without accompaniment, and with or without costuming. Participants may perform as a solo, duet or small group ensembles. Performances are limited to 3 minutes and 30 seconds. Limit of 2 entries. Options are:

Solo Vocal Performance Duet Vocal Performance Small Group Vocal Performance

INSTRUMENTAL DIVISION:

An instrument performance is an instrumentalist(s) playing standard musical instruments, with or without costuming or staging. Participants may perform as a solo, duet or small group ensembles. Performances are limited to 3 minutes and 30 seconds. Limit of 2 entries. Options are:

Solo Instrumental Performance

Duet Instrumental Performance

Small Group Instrumental Performance

DANCE DIVISION:

A dance performance is a dancer(s) doing body movements set to music. Participants may perform as a solo, duet or small group. Performances are limited to 3 minutes and 30 seconds. Options are:

Individual Dance Team Dance

SPEAKING DIVISION:

A speaking performance is any prose, poetry or traditional speech, whether presented as memorized or interpretive reading. Performances are limited to 2-5 minutes. Options are:

- **Prose/Poetry** Options include: prose reading, poetry reading, a memorized piece, storytelling (where the story is told and not read), or an interpretive speech (a speech that had originally been written and presented by someone else). You may edit your selection to meet the time requirement. Original poetry or stories can also be used. Presentations will be critiqued on use of introduction, voice, expression and appropriateness of material. You should prepare an introduction that includes credit to the author(s) and any transitions that are needed if you have more than one piece. NO props or costumes are permitted.
- Traditional Speech Pick a topic of your choice and write an original, factual speech about it. This could be about a 4-H project you love or a current issue you are concerned about. Your speech could inform, persuade, or motivate your audience. You may use note cards during your presentation, but do not read your speech from your notes. You may also use visuals (posters, charts, diagrams, power point) to help you deliver your speech, but NOT props or costumes. (Keep in mind, this is a speech, not a demonstration.)

DEMONSTRATION DIVISION:

A demonstration shows the audience several steps in a process and may be performed individually or with another youth as a team. Demonstrations are limited to 5 minutes. Options are:

Individual Demonstration

Team Demonstration

ARTS & CRAFTS DIVISION:

This division includes any visual artwork, including drawing, painting, sculpture, and crafts. All art, drawing and painting must be original work. Crafts can use a pattern or kit. Exhibits must be matted, framed, or otherwise ready for display. Exhibits should be labeled with name, club, grade. Limit of 2 entries. Options are:

2D - drawing, painting and flat artwork

3D - sculpture, crafts and other 3 dimensional artwork

PHOTOGRAPHY DIVISION:

This division includes any digital photo (color or black & white) taken by the youth. Photos must have been taken after October 1, 2023. Limit to 2 photo entries.
